Regulations

- Demonstrations must be confined to designated demonstration areas only and must fit within the confines of your display lot unless additional demo space has been purchased.
- Demos must be approved by Infrastructure Resources LLC (IR) prior to the event.
- No food can be sold or given away at the show without permission from IR. IR reserves the rights for all concessions.
- Exhibitor agrees to return the exhibit lot to its original condition. This includes removing all concrete, buildings and other material placed by Exhibitor.
- Exhibitor agrees to pay all taxes incurred as a result of leaving his exhibit on the show ground from year to year.
- Reserved space is for exclusive use of client.
- No brokering or subletting of space permitted.
- No displays are to be dismantled prior to official closing time.

Show Specifications

Storage or service areas occupied by Exhibitor on either side of the main structure will be considered as part of the main structure in determining rental charge. Exhibitor shall not erect any exhibit or other structure that exceeds the Exhibitor's lot dimensions. For those vendors with permanent structures, you are solely responsible for all damage to your building or property they rest on. If you elect not to renew your space or the show site lease is terminated, you will be given 90 days to remove your building or structure. If the task is not completed within 90 days, IR reserves the right to hire labor and bill your company. Exhibitors are required to return their exhibit site to its original condition when the Exhibitor chooses not to continue to display. This includes the removal of concrete, buildings, waste materials, herbicides and any other material placed there by the Exhibitor.

Exhibitor agrees to abide by the laws of the State of Illinois during the period this lease is in effect. All applicable taxes and license fees due from sales at Underground Focus Live! will be the sole responsibility of the Exhibitor. This includes sale, real estate, state, city, county and federal taxes.

The Exhibitor shall not become an agent of IR or have the authority to bind IR in any manner by reason of this contract. This contract is not to be construed as a partnership, but only as a lease to be paid for on a rental basis. The Exhibitor agrees that IR shall not be held liable for any salaries of any employees of the Exhibitor, or for any expenses incurred by the Exhibitor, or for any debt contracted by the Exhibitor.

The parties agree that it is foreseeable that the Exhibition may be canceled due to inclement weather, Acts of God, or other acts or occurrences beyond IR's control. The parties further agree that IR shall in no way be deemed to have guaranteed the performance of the Exhibition. Therefore, the Exhibitor agrees that in the event the Exhibition is canceled by reason of inclement weather, Acts of God, strike, lockouts, acts of the elements, or other acts of occurrences beyond IR's control, the Exhibitor shall not have any right of claim for refund against IR for money paid by the Exhibitor to Underground Focus Live! pursuant to this contract.

The Exhibitor assumes full responsibility for property damages, personal injury, or death to any party arising from or connected with Exhibitor's participation in the show. Exhibitor agrees to defend, indemnify and hold harmless IR and its agents and employees from all liability which might ensue from any Act of God, negligence, product liability, or other cause whatsoever, arising out of or incident to Exhibitor's participation in the show and not attributed to IR. Each Exhibitor must safeguard his goods, materials, equipment and display at all times and wherever the same may be located within, on, or about the premises. IR will employ general overall watchmen for the period of the show, but IR will not be responsible for property damage or loss, by or for any cause, and Exhibitor hereby waves any right to claim liability against IR for the same.

Electrical Requirements

If electricity is required in your exhibit, you must notify IR of your intention to use electricity upon the signing of this Agreement. The number of lots that are supplied with electricity at Underground Focus Live! are limited and therefore the electrical requirements of each Exhibitor will be a factor in determining lot selections. IR reserves the right to reassign exhibitors who do not require electricity to locations that are not supplied with electricity, or if you elect to stay in the same location, you will be charged for power.

Insurance

Each Exhibitor is required to be covered by, and provide a certificate of Public Liability Insurance (naming Infrastructure Resources LLC and Underground Focus Live! as coinsureds therein). Either a split limit in the amount of \$500,000 for injury to each person and \$1,000,000 for each occurrence and \$250,000 property damage or a combined single limit of \$500,000 to protect against claims arising out of the operation of its exhibit. The Exhibitor, upon signing this contract, expressly releases Underground Focus Live, Infrastructure Resources LLC, and from, and agrees to indemnify them against, any and all claims for loss, damage or injury to Exhibitor's exhibit, itself, or its employees not caused by IR negligence. Any damage to the premises through carelessness or otherwise by the Exhibitor or its employees must be paid for by the exhibitor.
